All person in Florida shall continue to limit personal interaction outside of the home and continue to practice all universal precautions recommended by the CDC. Avoid congregating in large groups and avoid nonessential travel (including within US with significant presence of COVID-19).	
<i>Senior citizens and individuals with a significant underlying medical condition(s) are strongly encouraged to stay at home and take all measures to limit the risk of exposure to COVID-19.</i>	
Commercial restrictions and guidelines effective May 4, 2020	
Restaurants	Dining rooms may open with appropriate social distancing and 25% capacity (15-sq.ft. per person per NFPA 101:7.3.1.2). Outdoor seating is also allowable with appropriate social distancing. Appropriate social distancing requires maintaining a minimum of 6-ft between parties, only seating parties of 10 or less. Bars and counters shall remain closed.
Gyms and Fitness Centers	Closed by Executive Order 20-71 on 3/20/20, expiring 5/6/20. Remain closed per EO 20-112.
Bars, Pubs, and Nightclubs	Closed by Executive Order 20-68 for 30 days effective 3/17/20. Closed by Executive Order 20-71 on 3/20/20, expiring May 6, 2020. Remain closed per EO 20-112.
Retail Stores	May reopen with 25% capacity and continue with guidelines from the CDC and OSHA.
Museums & Libraries	May reopen with 25% capacity. Any interactive functions, exhibits and play areas must remain closed.
Vacation Rentals	Closed by Executive Order 20-87; expired 4/9/20 then extended by Executive Order 20-103 to 4/30/20. Prohibited under EO 20-112.
Hotels & Lodging	Continue to operate as essential business and follow State of Florida, CDC, and OSHA guidelines.
Medical Procedures	<p style="text-align: center;">Elective procedures may resume if:</p> <ul style="list-style-type: none"> • Facilities have the ability to convert surgical beds to ICU beds for Covid-19 patients if needed. • The facility has adequate PPE to complete all procedures and respond to Covid-19 treatments, without seeking assistance for PPE <ul style="list-style-type: none"> • The facility has not sought additional PPE assistance since resuming elective procedures. • The facility has not refused to provide support to and proactively engaged with skilled nursing facilities, assisted living facilities and other long-term care residential providers.
Essential Businesses	Continue to operate as essential business and follow State of Florida, CDC, and OSHA guidelines.
Non-Essential Businesses (not specified in EO 20-112)	Unless otherwise stated, all other businesses shall remain closed during Phase-1 of reopening. <i>*Businesses with on-site retail sales shall comply with regulations for Retail Sales listed above.</i>
